

Locals on Track

The Locals on track initiative, organized by Formula E Race Operation Ltd with its registered office in Shortlands, 9th Floor 3, London, will be held in Rome on Friday 8 April 2022, on the occasion of the Roman leg of the Formula E World Championship Season 2021/2022, the 2022 Rome e-Prix (hereinafter, the "Event").

Participation will be free and open to a maximum of 500/1.000 Participants upon registration on the website www.fiaformulae.com/rome

This document defines the general rules of the Event (hereinafter referred to as the regulation).

1 THE ROUTE

Participants will be able to access the Rome E-Prix circuit between 18.00 and 19.00 on Friday 8 April 2022.

All Participants must complete the accreditation procedure at the dedicated desk (GATE SUD 1 - Viale Asia) and for the general brief of the Event at 17.00.

The Organizer reserves the right to limit the stay on the track based on activities related to the E-Parade and / or other activities on the track that could be concomitant.

2 CONDITIONS OF PARTICIPATION

To participate in the Event you must be at least twelve (12) years old by April 7, 2022.

For Minors Participants:














- From 12 to 15 years of age, they must be accompanied by a parent or legal guardian or with parental responsibility in the accreditation operations and on the track (Print and sign 'Annex 1 - Waiver');
- From 15 to 18 years of age, Participants will be able to access the track without a companion subject to the presentation at the desk of the required waiver Annex 1 - Waiver signed by a parent or legal guardian or exercising parental authority.

4 PARTICIPATION KIT WITHDRAWAL

Each registration entitles you to a participation kit.

The kit can be collected upon presentation of the identity card of the minor and of the parental responsibility holder and will be distributed exclusively on April 8, 2022 starting from 5pm and until 6pm at the accreditation desk (GATE SUD 1 - Viale Asia).

It is absolutely forbidden to give your participation kit to third parties, even in the event that you no longer intend to participate in the Event.

The organization assumes no responsibility in the event of an accident originated from the above circumstances.

5 GENERAL SERVICES

The safety service will be guaranteed by the runway assistance staff (Marshall), while the first aid service will be guaranteed by the medical staff on site.

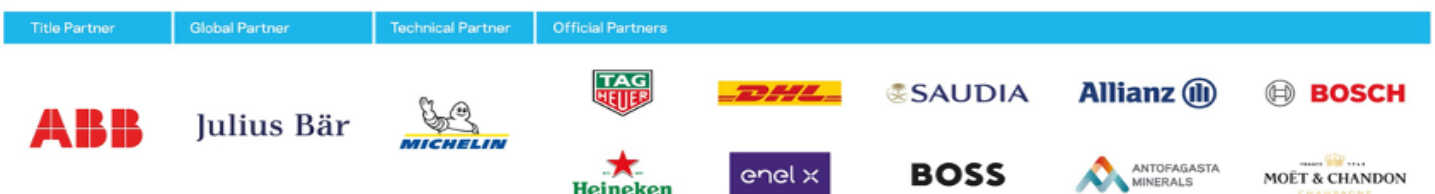
6 ACCESS TO THE EVENT PLACES AND SECURITY

To access the premises of the Event, the Participant and any of its the guardian or parent exercising parental responsibility expressly acknowledge and accept that the Organizer may use security personnel, who will be authorized to check both people and their personal effects. Anyone wishing to access the venues of the Event agrees to undergo such security checks. In case of refusal, the Participant will not be authorized to access the venue of the Event or to participate in it.

7 INSURANCE

Civil liability: in accordance with current legislation, the Organizer has taken out a third party liability insurance to cover any damage that all Participants to the Event, as well as those exercising parental responsibility, may suffer. Such third party liability insurance will be triggered only in case of accidents suffered by the Participants during the Event.

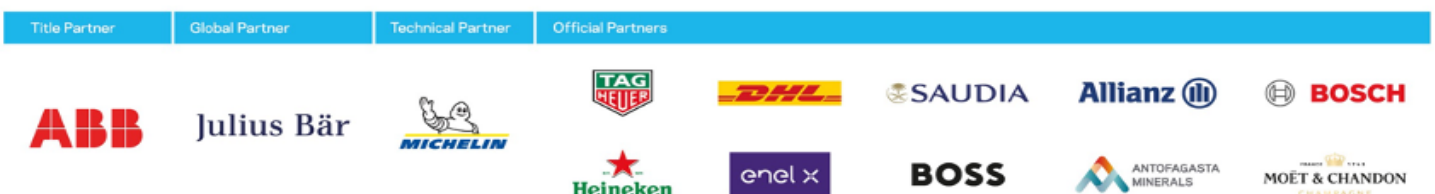
9 RESPECT FOR THE ENVIRONMENT
